- 1) You agree to carefully look, appreciate and consider all Artworks in the gallery.
- 2) You agree to spend at least five minutes looking at each Artwork in the show and to read the press release and all relevant documention surrounding the Artworks.
- Should any of the artworks be to your liking, you agree to pursue a conversation with Gallery 3) to find out more information concerning availability.

- 5) You agree to share a minimum of one image of the exhibition on show when you are entering Gallery in at least two of the three social media platforms described in term 4.

- If you come and ask for directions to the other galleries in the street, you agree to stay for a 14) minimum of 5 minutes at Gallery looking at the Artworks.
- 15) Gallery reserves the right to expel any and all visitors to the gallery should visitor not act in accordance with this implicit agreement.
